Presentations/ Recognitions

The Board of Trustees recognized State Representative Tan Parker for his support of the district and public education in Texas. Representative Parker most recently served as the Chairman of the House Committee on Investments and Financial Services and consistently finds ways to champion economic development and job creation. And despite Denton ISD encompassing a small portion of District 63, which he represents, Rep. Parker can always be counted to reach out to our educational leaders and gather input before tackling legislative issues in Austin.

The College Board honored 130 Denton ISD high school students with distinctions for 2015, according to their annual list of recipients who are named Advanced Placement (AP) Scholars. The national program recognizes individuals who have demonstrated college-level achievement though exceptional scores in AP courses and on AP exams. Students are awarded based on four levels including: AP Scholar, AP Scholar with Honor, AP Scholar with Distinction and National AP Scholar.

Denton High School's Lillian King has joined an elite group of scholars by earning one of the highest academic honors in the country. She is among the highest scoring entrants from the state of Texas in the 2015 National Merit Scholarship program.

Additionally, nine Denton ISD students were recognized as Commended

Scholars by the National Merit Scholarship program. There are less than 34,000 students recognized nationwide, placing these student's scores on the PSAT/NMSQT in the top five percent.

Public Hearing for Texas Academic Performance Report (TAPR) Public Hearing for the Academic Performance Report opened at 6:40

Members of the division of curriculum, instruction and staff development conducted a Public Hearing on the Texas Academic Performance Report (TAPR), which replaced the AEIS report. Lyneille Meza, Director of Data and Assessment gave an overview of student performance for Denton ISD.

Lyneille also reported Denton ISD was 100% compliant with the Federal No Child Left Behind (NCLB) Act. This Act requires that all academic classroom teachers* must be Highly Qualified (HQ) in the areas they are assigned to teach. In general, under the No Child Left Behind Act (NCLB), the Highly Qualified (HQ) teacher must possess the following:

- Bachelor's Degree
- Full State Certification
- Demonstrated competency in the core academic subject taught (passing of the appropriate content area test)

Marcia Kellum, Coordinator of reading recovery, and Carmen Lipscomb, Reading Recovery Teacher/Leader, presented the Early Literacy Inventory (ELI) and the Spanish Early Literacy Inventory (SELI) reports. the annual report of kindergarten literacy with highlights that show 92 percent of the kindergarten students, 91 percent of the first graders and 91 percent of the second graders were Stage 2-3 (Progressing / On- Level) by the end of last school year. The outcomes also show significant growth in all the literacy

measures. The Spanish component highlights that 88 percent of the bilingual kindergarten students, 86 percent of the first graders and 88 percent of the second graders were Stage 2 -3 (Progressing / On-Level) by the end of the year. The outcomes also show significant growth in all the literacy components.

Willie Hudspeth addressed the Board expressing his concerns with students that he feels still cannot read or are unable to do math problems and wants to know what can be done to assist these students.

Denton ISD – Quarterly Growth Report 3Q15 Jeff Baker with Templeton Demographics provided the Board with the 3rd quarter growth report. DFW job growth rate is 3% and has created 98,700 new jobs in the past 12 months which is 50% more than the national rate of 2.0%. Denton ISD has approximately 30,678 future lots, the average price of a home in Denton is \$229,280 with an average of 37 days on the market. Paloma Creek, Providence and Cross Oaks elementary zones have the most home activity, representing 43.5% of annual new home starts. 2020/21 enrollment projection is 30,692 students with a projected enrollment of 34,750 students for the 2025/26 school year.

He introduced two Guyer High School engineering students, Jaazeel Valles and Cameron Ogrodnik, who will be assisting with tracking and report generation moving forward. It was reported that the district's consumption of electricity, natural gas and water decreased by at least 2 percent, which coupled with higher usage rates, resulted in an increase of \$157,950 during the same period as the year before.

Bell Elementary School is underway with gymnasium, cafeteria and fifth grade wing well underway. Paving and geo thermal wells on the site are near completion.
