### EXHIBIT "A"

## I. OPERATING MILLAGE RENEWAL PROPOSAL

This proposal will allow the school district to continue to levy the statutory rate of 18 mills on all property, except principal residence and other property exempted by law, required for the school district to receive its revenue per pupil foundation allowance. The remaining .4568 mill is only available to be levied to restore millage lost as a result of the reduction required by the "Headlee" amendment to the Michigan Constitution of 1963 and will only be levied to the extent necessary to restore that reduction.

Shall the currently authorized millage rate limitation on the amount of taxes which may be assessed against all property, except principal residence and other property exempted by law, in the Livonia Public Schools School District, Wayne County, Michigan, be renewed by 18.4568 mills (\$18.4568 on each \$1,000 of taxable valuation) for a period of 5 years, 2016 to 2020, inclusive, to provide funds for operating purposes; the estimate of the revenue the school district will collect if the millage is approved and 18 mills are levied in 2016 is approximately \$22,965,000 (this is a renewal of millage which will expire with the 2015 tax levy)?

# II. MILLAGE RENEWAL PROPOSAL BUILDING AND SITE SINKING FUND TAX LEVY

Shall the currently authorized millage rate of 1.12 mills (\$1.12 on each \$1,000 of taxable valuation) which may be assessed against all property in Livonia Public Schools School District, be renewed for a period of 5 years, 2015 to 2019, inclusive, to continue to provide for a sinking fund for the construction or repair of school buildings and all other purposes authorized by law; the estimate of the revenue the school district will collect if the millage is approved and levied in 2015 is approximately \$4,592,000 (this is a renewal of millage which will expire with the 2014 tax levy)?
