<u>Meeting Called to Order</u>: Tammy Hawkins, Board President, called the Board of Trustees Meeting to order at 6:00 p.m.

Opening Remarks by Superintendent: In Dr. Muri's opening remarks he spoke briefly about this being a big week of STAAR testing across the school district, he reminded Trustees that graduation ceremonies begin next week with lots of celebrations to go along with it, including that this Sunday would be the Outstanding Teachers Picnic honoring the 43 campus 'Teachers of the Year' and their families. He also thanked the 61 members of the community bond committee for the hundreds and hundreds of hours volunteering to review facility needs, form bond recommendations, and then campaign on behalf of the district.

Board Policy

Discussion of Revisions to Local Board Policies for The District of Innovation Renewal Plan: Associate Superintendent of Human Capital, Operations and Athletics Anthony Sorola, Ed.D. presented this item for discussion. Trustees discussed revisions to local board policies for the District of Innovation (DOI) renewal plan. (Trustees had recently approved the ECISD District of Innovation Plan and the related exemptions from state statutes) This report reflects the revisions and updates to local policies that are most pressing due to their impact on staffing and the start of school in 2022-2023. Texas Association of School Boards Policy Service assisted the District in proposing revisions and additions to ECISD board policy. These policies will be brought back for a second read and vote on May 17, 2022.

<u>M.S. Doss Foundation of Seminole</u>: Moved by Abalos, seconded by Gregg to approve Resolution to submit Grant Application to M.S. Doss Foundation of Seminole as presented. This grant request is for \$80,000 for a playground at Carver Early Education Center to promote physical development for children ages 3-5 living with disabilities. Accessible equipment is needed so that all children can use it with greater independence and greater interaction with peers.

Report/Discussion Items

<u>Discussion of Compensation Plan</u>: Associate Superintendent of Human Capital, Operations and Athletics Anthony Sorola, Ed.D. and Executive Director for Human Resources Staci Ashley presented this item for discussion. Trustees discussed the compensation plan for the 2022-2023 school year. Compensation is a key piece of recruiting and retaining highly effective team members, and ECISD has focused on raising pay and improving benefits for employees. Each year, ECISD's Human Capital Department, with the Texas Association of School Boards (TASB), conducts a salary maintenance study to try to ensure

the compensation schedule is competitive with other school districts and local markets. Dr. Muri made five compensation recommendations to Trustees:

- 3% (of midpoint) pay increase for all campus-based professionals
- Starting teacher pay increase to \$58,750 (currently \$57,000); all teachers receive a \$1,820 increase
- 2% (of midpoint) pay increase for all central office professionals
- 4% (of midpoint) pay increase for all hourly employees (school-based or central office)
- Raise minimum wage to \$15/hour (this is up from \$10/hour two years ago)

Trustees will look at these compensation recommendations as it finalizes a budget for next year. Individual questions from employees may be directed to Human Resources Department.

25894 **Presentation of ECISD Innovation Department**: Chief Innovation Officer Jason Osborne and Research & Innovation Strategist Dr. Kristin Whittenburg presented this item for discussion. The ECISD Innovation Department offered the school board an update on its work which is dedicated to steadily improving systems and processes by building capacity in ECISD to implement and embed breakthrough innovations. PICK Education, one of the Innovation Department's first initiatives, is a philosophy of building a network of partners in which students and teachers collect data and contribute to real-world university research. An accredited neuroscience course and use of Virtual Reality are a couple of leading-edge classroom experiences available to ECISD students now. The Student Spaceflight Experiments Program (SSEP), introduced by the Innovation Department, gives students a chance to develop a science experiment to be conducted by astronauts on the International Space Station. The Innovation Department also reaches across departments to support projects like the district's badging system.

Presentation of ECISD Athletics Department: Executive Director of Athletics Tracey Borchardt presented this item for discussion. ECISD offers 15 varieties of boys and girls sports with 208 teams from 7th grade through varsity athletics and 174 UIL certified coaches. Did you know, more than 4,400 students from middle school and high school played 2,270 games (August to May) with varsity teams traveling 165,000 miles in the process? Attendance by athletes is at 95.6%, and the four-year graduation rate for students in athletics is 95.5%. This year 32 of the 38 teams made the playoffs in their sports. Character development and community service are other aspects of each athletic program. Student-athletes and their coaches volunteer and fundraise on behalf

of a number of organizations, a reminder of how much ECISD students and staff give back to the community that supports them. New things coming include a parent-student engagement class and online ticketing.

<u>Discussion of Redistricting Maps</u>: Redistricting Committee Chair and Board of Trustee Delma Abalos along with Superintendent Dr. Scott Muri presented this item for discussion. Trustees discussed redistricting maps for the school board members' positions. The Ector County Redistricting Task Force has been working for several months to update school board member districts based on changes in the 2020 Census population numbers. The Task Force of ECISD, Odessa College and Ector County Hospital District worked to make each district equal and fair. In the accompanying map, the red lines mark the current ECISD boundaries and the colors designate the proposed changes. A public hearing will be held Monday, May 16, at 5:30 p.m. in the ECISD Board Room and ECISD Trustees plan to vote on the changes next Tuesday, May 17, 2022.
