We recommend the following be presented to the Board of Education.

On Thursday, January 29, 2026, at 2:00 p.m., bids were received from six contractors for the Skyview Middle School Gymnasium Wall at Skyview Middle School. A bid tabulation is attached for your review. CJC Construction, from Hanover, Minnesota submitted the low base bid in the amount of \$83,000.

As discussed with the Facilities Team, we are also recommending award of Alternate No. 1 Cross Court Divider Curtains.

Alternate No. 1 Cross Court Divider Curtains Add \$55,000

This alternate provides and installs additional gymnasium divider curtains and associated work including demolition of existing cross court divider curtains.

We recommend awarding the contract to CJC Construction as follows:
