## Our A/B schedule was in place between October 15 through Thanksgiving break. District students are currently learning remotely through January 15 (with January 18 as a holiday).

The earliest possible date for a return to in-person learning would be January 19, 2021.

We are reviewing plans to reopen our schools to full in-person instruction/optional remote via live streaming with the same classroom teacher utilizing our regular school day schedules.

Students would continue with their current teacher(s) regardless of the option selected by the parent.

# Supt. Advisory meetings held to discuss challenges

November 30-December 18 Pivot to remote due to staffing challenges

Supt. Advisory meetings took place on December 8 and December 14. The purpose of each meeting was to review building-level plans to reopen schools to full in-person instruction. The goal of each meeting was to listen to the team members share their work related to the development of a sustainable full in-person/optional remote learning plan (daily livestreaming with the classroom teacher).

Two challenges were central to the conversation from each building team: leveraging social distancing to the greatest extent possible and creating emergency staffing plans for use during quarantines.

## Leveraging social distancing to greatest extent possible

The teams universally supported the need for full transparency with parents on the issue of <u>social distancing</u>. As such, the following paragraph was included in the introduction to the parent survey:

The District removed classroom furniture to distance desks as far apart as possible so that social distancing could be to the greatest extent possible. During A/B schedules (50% capacity), six feet of distance was observed when possible. With additional students in attendance, social distancing will likely be reduced to between 2-4 feet, even when students are unmasked for lunch and snack. This may increase the number of students who would need to quarantine should there be a need for contact tracing of close contacts.

## Staff support

Connection between metrics and learning model - school metrics vs. community metrics

Increased coverage support to be available if needing to quarantine – school staffing plans

Clear contact tracing explanations for staff and educating all staff on who and when a quarantine will go into effect – handled by nurses

Documenting who is in classrooms and when – will assist with contact tracing

Mental health and wellness opportunities available: -Employee Assistance Program & wellness portal through health insurance co-op -Internal 161 SEL SharePoint site with documents, suggestions, and guidance

## Family support

Important to remember the impact this has on students.

Be proactive in welcoming back in announcements, videos and through PBIS.

Support students by talking about how full in-person students will be different but also similar.

Review procedures and expectations for social distancing, mask wearing, and increased hand washing.

Address need for increased support - allowing students to discuss and talk about COVID-related concerns.

## When in-person learning resumes: 5-part ISBE/IDPH guidelines



Clean all "high-touch" surfaces every day.

High touch surfaces include counters, tabletops, doorknobs, bathroom fixtures, toilets, phones, keyboards, tables and bedside tables. Use a household cleaning spray or wipe, according to the label instructions. Labels contain instructions for safe and effective use of the cleaning product, including precaturions you have when applying the product, such as wearing gloves and making sure you have good ventilation during use of the product.

**Physical spacing** will be maintained to the greatest extent possible. Our classrooms have been rearranged by removing all extraneous furniture, small group stations, etc. to create more space to spread out. During A/B schedules (50% capacity), six feet of distance was observed when possible. With the proposed change and additional students in attendance, social distancing will likely be reduced to between 2-4 feet, even when students are unmasked for lunch and snack.

No more than 50 individuals may gather in one space: lunch - combination of classroom and other spaces; hallway traffic staggered and monitored; arrival/dismissal procedures modified.

**Parents will self-certify** that their child is free of COVID *symptoms one hour* prior to the bus stop or entering a school building. Symptom-free does not mean virus-free which is the reason for the other precautions in place.

More frequent cleaning and disinfecting throughout the school day: custodial schedules staggered to maximize in-person cleaning/disinfecting; HVAC system fresh-air mix/optimal temperature and humidity settings maximized; scheduled filter changes.

## **In-person learning logistics**

- Teachers will live stream their in-person lessons to students at home (should they have remote learners in their class).
- Daily schedules will follow standard school bell schedule and hours.
- Current class and teacher assignments will be unchanged unless required by teacher absence or leave.
- Student absences will utilize normal reporting procedures.
- Buses will run their regular routes; a maximum of 50 people will be maintained on each route.
- Students are assigned a seat and are expected to wear a face mask.
- Buses will be sanitized according to D210 protocols.

## **Transitioning between the options**

Daily transitioning between learning options was challenging for staff members to ensure all students were accounted for in a timely manner.

Moving forward, for planning for the continuity of instruction, if a parent chooses full in-person and extenuating circumstances cause a reversal of their decision, the student would become a remote learner for the remainder of the trimester (March 5).

If a parent chooses full remote and determines extenuating circumstances cause a reversal of their decision, the student would become an in-person learner for the remainder of the trimester (March 5).

Both reversals would require consultation with the building level administrator and will follow a five-day period to allow for preparations.

Students who need to quarantine would immediately become remote learners.

## **Sustainability - Adaptive Pause**

When staffing coverage, or the health of individuals, affect the continuity of student learning, an adaptive pause would be utilized.

Adaptive pauses by school, grade-level or class would allow for continuation of others. This is a parent communication piece as it could be difficult on families depending on how much it is used.

Families with students in other buildings who are not on an adaptive pause, may still attend school as long as they are healthy and are not considered close contacts to any COVID-19 positive cases per IDPH school guidelines and local health department.

## Recommendations

The District's recommendation is to return on January 19, 2021 following a hybrid A/B model for two weeks. Then, move to a full in-person return of all students Monday, February 1, 2021.

Building communication with parents would begin on December 17, 2020. Parent commitment form for full in-person model can be accessed beginning January 4, 2021.

## **Additional Recommendations**

English Learners will return to full in-person for five days per week on January 19, 2021.

The following special education programs would return to full inperson for five days per week on January 19, 2021:
