### **Counseling and Guidance Program**

### Goals

The district's counseling and guidance program is based on the district's educational philosophy:

District schools, in partnership with families and communities, provide each student the opportunity to develop values, knowledge, skills and self-confidence to become lifelong learners and responsible citizens.

The goals of the guidance and counseling program are designed to support the educational development of each student. The student will:

- 1. Develop decision-making skills;
- Obtain information about himself/herself;
- 3. Understand the opportunities and alternatives available in his/her school's educational program;
- Set educational training and career goals;
- Accept increasing responsibility for his/her own decisions;
- 6. Develop skills in interpersonal relations;
- 7. Utilize school and community resources.

### Responsibilities

Each school guidance and counseling program will operate under the direction of the school principal. School staff members, including counselors, teachers, secretaries, aides and others carry out guidance and counseling activities as organized and directed by the school principal. The school principal will assign guidance and counseling personnel in accordance with their training and background.

The districtwide coordinator of the guidance and counseling program will be provided by the district superintendent or his/her designated representative. Also, periodic evaluation of the guidance and counseling program will be the responsibility of the superintendent who will report to the Board on the extent to which the program goals are being met.
