ACTION

BACKGROUND INFORMATION:

The Business Office has revisited its projection for FYE 6/30/10 operating results. The newest projection of our final audited operating results for the General Fund has been increased from an operating surplus of approximately \$400,000 for FYE 6/30/10 to and operating surplus of approximately \$450,000.

This means we DO NOT expect to incur the budgeted 2010 operating deficit of \$295,610 that would lead to a year end General Fund Balance of \$2,337,308. Instead, we expect to end the 2010 year with a General Fund Balance of \$3,082,918.

Additionally, as shown in the information item contained the previous agenda item, we now expect tax revenues of the General Fund to be approximately \$99,000 greater than we have budgeted for the 2011 year.

We have discovered that the District will have to add an additional bus route for the 2010-2011 school year due to increased enrollment and other considerations. This additional route will strain the limited number of buses in our fleet and the increased distances of our new athletic district will further strain our ability to run regular bus routes and transport students to games and contests across the new athletic district.

Therefore, the administration believes we should purchase an additional new bus large enough to carry 90 young children when used as a route bus and 60 teenage students when pressed into "out of town" service.

The cost of such a bus purchased through the HGAC buy board should be below \$99,000.

The administration is therefore seeking approval to buy such a bus and a General Fund Budget amendment of \$99,000 to make that purchase.

This budget amendment DOES CHANGE the district's GENERAL FUND BALANCED BUDGET to a DEFICIT BUDGET of \$99,000.

PRESENTATION / PURPOSE:

This is the presentation of a budget amendment that will allow the purchase of a new school bus costing approximately \$99,000 (or less) and create a 2011 General Fund Budget Deficit of \$99,000.
