Sean Schafer, Kevin Spellman, and I represented the Board at this conference, which was held at the Eagle Crest Resort in Redmond, OR. Also in attendance from the MESD were Barbara Jorgensen, Kelvin Webster, Heyke Nickerson, Jim Rose, Judy Custy, and Leslie D. Nelson .

Jim Mabbott, the Executive Director of OAESD organized this program. Nearly 90 attendees included representatives from most of the state's ESDs with Board members, Superintendents and/or senior staff. Our executive secretary worked the entire conference directly with more than 35 vendors representing educational organizations, medical companies, technology companies, crisis management consultants, and other private business partners with the educational community. Her work generated approximately \$ 20,000 in revenues for OAESD. Clearly, both the educational components of the conference, as discussed below, combined with the working activities of the vendors, contributed to the success of this statewide meeting.

The program consisted of:

- (1) Thursday afternoon discussions with the Governance Council, Special Education, and School Improvement sessions.
- (2) Friday sessions included a lengthy discussion of the Oregon Education Investment Board and its new product of Achievement Compacts, by Tim Nesbitt, the staff director of the Board, and Board member Mark Mulvihill, also Intermountain ESD Superintendent.

A second discussion examined Systems of Care as a Framework for Multidisciplinary Collaboration among state health, criminal justice and human service agencies.
