- a. This week ODE announced that *additional reopening requirements* to the "Ready Schools, Safe Learners" will be announced on January 19th. Based on this news, it is our hope that the district will be able to reopen schools to onsite learning as outlined in the tentative schedule below:

**Proposed schedule:**

- **January 11 - January 21, 2021**
  - All K-12 students in Comprehensive Distance Learning from home
- **January 25 - January 28, 2021**
  - All K-5 students return to in-person learning
  - 6-12 students in Comprehensive Distance Learning from home
- **February 1, 2021**
  - 6-12 students return to in-person learning in a hybrid schedule
