I would appreciate your consideration of a request for the following class fees for orchestra.

\$63 concert black dress for ladies \$117 concert tux for men

The concert dress and tux are a one-time purchase I request students to make as a 9th grade student. The dress and tux are worn for every performance made throughout the school year (on average 10-15 times). Unless the student drastically changes size their concert clothes will last them the entire four years they attend Minico High School and can even be used for formal dances and future events they attend after high school.

\$30 per trimester for instrument rental fee

This money will go towards the following things

- Pay for the replacement of strings (strings should be replaced at least once a year. One set of strings for violins/violas can cost approx.. \$40-\$80, one set of strings for cellos can cost approx.. \$150-\$200) (Bass strings only need to be changed once every 5-7 years. One set of strings for a bass can cost approx.. \$150-\$250)
- Pay for the replacement of new bows (bows on average if taken care of well last 3-7 years depending on quality and use. A new violin/viola bow can cost approx.. \$50-\$100. A new cello bow can cost approx.. \$75-\$110. A new bass bow can cost approx.. \$95-\$130)
- Pay for minor repairs to instruments (seam separations, broken pegs, broken fine tuners, facial cracks, broken chin rests. Repairs can cost approx.. \$35-\$150.)

*A good school instrument that passes from student to student will have an average life span of 10-15 years depending on how well it is taken care of and maintained. *

 uniforms. This next year I'm hoping to buy a new canopy with the Minico logo on it, so that we
 look better at our meets. The money also goes to pay meet entry fees, end of the season
 dinner, activities at state, end of the season awards, senior gifts, updating the medical kit, and
 to reduce the cost on team shirts and/or sweatshirts (or spirit packs).
- On a yearly basis, Cross Country spends about \$1000 plus any extra things like new uniforms, a canopy, and other supplies being added on top of that amount. Uniforms were \$900 last year and I'm hoping to have to buy more if I get more than 30 kids to come out and run. The new canopy will cost about \$1400 this next year. Entry fees cost about \$200-\$300 every year depending on the meets. The end of the year things cost about \$250. Activities at state costs about \$100-\$200 depending on how many kids make it to state. Everything else is put towards the athletes and trying to keep their costs down to help make it feasible when buying team shirts and other things, but these are entirely voluntary.
- Last year was the first year of using the letter and we received around \$1200 in donations from local businesses, relatives, parents, and others. It was a very successful fundraiser for what we need to do with the only cost coming in envelopes, paper, and stamps.
