BACKGROUND INFORMATION:

- Per Section 44.002 of the Texas Education Code, "the Superintendent shall prepare, or cause to be prepared, a proposed budget covering all estimated revenue and proposed expenditures of the District for the following fiscal year."
- The budget must be prepared according to generally accepted accounting principles, rules adopted by the State Board of Education, and adopted policies of the Board of Trustees.
- Budgets for the General Fund, the Child Nutrition Fund, and the Debt Service Fund must be included in the official district budget and must be adopted by August 31.
- As noted in the March 2019 monthly financial reports for the 2018-2019 fiscal year, revenues to date are meeting, and in some cases exceeding, budget projections. Expenditures to date are also meeting budget projections.
- The District's 2019-2020 budget development process is progressing on schedule.
 A copy of the updated 2019-2020 Budget Development Process and Calendar is included for your review.
- Since minimal additional budget development data has become available since the February 28 staffing/budget workshop, this evening we will discuss timelines for future budget data availability.
