Budget negotiations at the Capitol this month, as well as school aid budget recommendations. MASA anticipates the process will move along quickly. August 28, 2023 will be the first day of school next year. Negotiations with the VEA will be starting this month. The bargaining agreement expires at the end of June 2023.
