- 5. 1 Dr. Cumblad recognized the retirement of Dawn George and expressed gratitude for her continued support of Mid-Valley's programs and students.
- 5.2 Student and Staff Enrollment, May, 2012 Dr. Cumblad reported on enrollment being stable within the Mid-Valley programs, with the exception of Safe Schools. It is anticipated that the fall enrollment for this program will be higher than last fall.
- 5.3 Administrative Liaison Meeting, May 21, 2012 The minutes of

the Administrative Liaison Meeting were shared. Highlights of the meeting included a discussion of the shared professional development, the creation of new IEP goal pages, positive feedback from the behavior training sessions, and a change in some program names/program emphasis.

- 5.4 Grants Update The final IDEA amendments for FY 12 have been submitted and approved. The FY 13 application will be submitted after June 13. The Safe Schools grant has been submitted for the same amount as last year, \$146,500. The Alternative Learning Opportunities Program (ALOP) has been approved with requests for minor changes. The Illinois Association of Special Education Administrators Innovation Grant has been implemented. Staff members will present their results at the Winter IAASE Conference. The St. Charles Kiwanis Club awarded a grant of \$1,200 to purchase a wheelchair swing for MJC during the summer. Learning Ally recently awarded MVSEC a grant for two iPod Touch devices with some free applications. 5.5 Confidential Administrative Assistant Job Description -- It was
- 5.5 Confidential Administrative Assistant Job Description -- It was recommended that the Administrative Assistant to the Executive Director become a confidential position to assist with labor and negotiations matters. The proposed job description was reviewed with the Board.
- 5.6 MVSEC Administrator Job Descriptions As a part of the review of all job descriptions, the administrator job descriptions were also revised. The Board was presented with the job descriptions for the Program Coordinator, Behavior Technical Assistant,

Coordinator/Principal, and Director of Business/Human Resources. 5.7 Report from Behavior Technical Assistance was postponed until a later Board meeting.

- 5.9 August Schedule of Activities Dr. Cumblad presented the Board with a summary of the events for the beginning of the school year. These activities include: Initial and Refresher CPI training, New Staff Orientation Week, Mentor Training, Opening Day/Department Meetings, and a Family/Staff Picnic.
- 5.10. Business Partner Breakfast Dr. Cumblad reported that the Business Partner Breakfast was a great success. She thanked the superintendents who were present.
- 5.11 Graduations -- Dr. Cumblad presented the Board with the names of the 24 students who graduated or exited by age from the Mid-Valley Programs.
