ORDER CALLING ELECTION FOR NOVEMBER 7, 2017 TO RATIFY SCHOOL DISTRICT TAXES PURSUANT TO SECTION 26.08 PROPERTY TAX CODE

WHEREAS, the Board of Trustees (the "Board") of Ector County Independent School District (the "District") deems it advisable to call an election to ratify District taxes pursuant to Section 26.08, Tax Code, as hereinafter ordered; and

WHEREAS, it is hereby officially found and determined that said meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all as required by the Government Code, Chapter 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF ECTOR COUNTY INDEPENDENT SCHOOL DISTRICT:

1. That an election shall be held between the hours of 7:00 A.M. and 7:00 P.M. on November 7, 2017 ("Election Day"), in the District at the Vote Centers designated by the Ector County Elections Administrator (the "Elections Administrator") in accordance with the provisions of a joint election agreement and contract for election services with the Elections Administrator (the "Contract"), which the President and Secretary of the Board of Trustees and the Superintendent of the District are hereby authorized to execute in the name of said District. The locations of such Vote Centers are set forth in Exhibit A attached hereto. Exhibit A shall be modified to include additional or different Election Day Vote Centers designated by the Elections Administrator and to conform to the Contract.

2. That the early ballot board and all the election officers designated pursuant to law by the Elections Administrator are hereby appointed and confirmed to hold said election at said polling places and all early voting places.

3. (a) 3. (a) That early voting shall be conducted by personal appearance during the period early voting is required or permitted by law, being October 23, 2017 through November 3, 2017, at the following locations, dates and times:

4. That all resident, qualified electors of said District shall be entitled to vote at said election.

That at said election the following PROPOSITION shall be submitted in accordance with law, and the official ballots for the election shall be prepared in accordance with the Texas Election Code so as to permit the electors to vote "FOR" or "AGAINST" the PROPOSITION, which shall be expressed as follows::

FOR) APPROVING THE AD VALOREM TAX RATE OF \$1.28 PER \$100) VALUATION IN ECTOR COUNTY INDEPENDENT SCHOOL) DISTRICT FOR THE CURRENT YEAR, A RATE THAT IS \$0.109049) HIGHER PER \$100 VALUATION THAN THE SCHOOL DISTRICT) ROLLBACK TAX RATE, FOR THE PURPOSE OF CAPITAL ANDAGAINST) MAINTENANCE AND OPERATIONS.

6. That proper notice of said election shall be given and, in all respects, said election shall be conducted in accordance with the Texas Election Code.

7. This order hereby incorporates the provisions of the Contract, and to the extent of any conflict between this order and the Contract, the provisions of the Contract shall control. The Superintendent of the District is hereby authorized to correct, modify or change the information in

the attached Exhibits based upon the final locations, dates and times agreed upon by the Elections Administrator and the District as well as incorporate additional or different voting locations as designated by the Elections Administrator.
