Approve the increase to board fees charged students living on campus from \$1,700.00 a semester to \$1,800.00 a semester beginning with the fall of 2023.

Background and Rationale:

The College contracts with a food service company to provide food preparation and service for our cafeteria and board students. This agreement is reviewed each year for adjustments. Great Western Dining has requested an increase based on the cost of food away from home as calculated by the Department of Agriculture. Based on this year's request, the College would need to increase our 18 meal a week Board Plan from \$1,700.00 to \$1,800.00 a semester in order to keep the student's charge in line with the College's expense for providing the board plan.
