Objective: Services Provided, documentation and evidence for verification of residency of families for valid school enrollment. Our other service that will be provided is the testimony in all hearings that investigator may be called upon to attend. - ✚ Administrative Fee: (Report writing time and database analysis) \$25.00 Hour for Court Documents and All Administrative Costs

Data Base Search Only Price: \$ 5.00 per family if there is not a residency check done on flagged families that need an investigation.

We also offer to you the option of **Paperless Registration** at \$2.00 per family and this is for running every student within your district. We require a down payment of 50% before we can start the database searches. Once the database is run, we will go over the list with the district and automatically start investigating the families we feel are out-of-district due to the database information that we have retrieved. If the Database is ran and then the district decides to not allow us to investigate at least thirty percent of the families we flagged for investigation we will have to charge at Database Search only price. At no time can the investigations be stopped unless for poor performance on the part of National Investigations, Inc. Poor performance can only be construed as National Investigations, Inc. not performing the investigations in a professional and ethical matter by ILCS and IDPPFR.

Procedures: Prospect Heights School District #23 will fax, email, or submit a list of students to be run through National Investigations, Inc. proprietary database check system. National Investigations, Inc. will assign an investigator to the case. A hard copy of the investigator's report will be mailed to the district along with the invoice. All districts are required to follow the Prompt Payment Act (50 ILCS 505).



National Investigations, Inc. will also hold a \$5,000,000.00 general liability policy for your District.


