Re: Attendance Improvement Plan

Attached is the draft 2025-2026 Attendance Improvement Plan. There are no changes to the 2024-2025 plan. The Attendance Improvement Plan will be placed on the October agenda for approval. Board approval is not required, but is considered best practice.

Below shows the district changes in attendance over the last four school years in the three key metrics reported on the annual school report card.

- Illinois law defines "chronic absentee" as a student who misses 10 percent of school days within an academic year with or without a valid excuse. That's 17.5 days of an
  average 175-day school year. Excused absences may include illness, suspension, need to care for a family member, etc. Students need daily instruction in order to succeed.
  Chronic absentees are at risk of academic and social problems.
- 2. Illinois law defines "chronic truant" as a student who misses 5 percent of school days within an academic year without a valid excuse. That's nine days of an average 180-day school year. The count of chronically truant students does not include students with excused absences. Chronic truants are at risk of academic and behavioral problems.

  Research shows that chronic truancy has been linked to serious delinquent activity in youth and to significant negative behavior and characteristics in adults.

# DRAFT-ATTENDANCE IMPROVEMENT PROGRAM (Rev 10-16-2025)

#### Schools will:

- Monitor attendance as it relates to academics and behavior through the MTSS process.
- Contact the parent/guardian about student attendance concerns
  - Document student and parent/guardian contacts.
  - o Create individual attendance improvement plans for students with over fifteen absences
- Send an automated call to parents/guardians who have not called their student in as absent and prompt them to call
- Work with parents/guardians to improve student attendance

# Parents/Guardians will:

- Contact school when their student is absent and provide a reason for the absence
- Provide written excuses for medical or dental appointments
- Contact schools ahead of time with known appointments or engagements

#### Parent Family Liaisons and Other Designated Staff will:

- Work with students, parents/guardians and schools to improve student attendance
  - Student contacts
  - o Parent/Guardian phone contacts
  - Home visits
- Work with students, parents/guardians and schools to reduce barriers to school attendance
- Work with students, parents/guardians and schools to develop and implement attendance improvement plans
- Document all contacts with students and parents/guardians

# Five (5) Absences (Excused and/or Unexcused)

- The school will send a letter home detailing the importance of school attendance and cite the number of days absent.
   OR
- The parents/guardians will be contacted by the student's homeroom teacher to discuss the absences and discuss parent/guardian concerns that may be resulting in the student's absences.
- Schools will document the contacts on the designated tracking document.

# TEN (10) ABSENCES TOTAL (Excused and/or Unexcused)

- The school will send a letter that includes information from the "unlawful absences" letter from the ROE.
- The school will send a letter home detailing the importance of school attendance and cite the number of days absent.
- The school will schedule a meeting and meet with the parent/guardian to discuss the absences and discuss parent/guardian concerns that may be resulting in the student's absences.
- If the parent/guardian does not attend the scheduled meeting, a Parent Family Liaison or Other Designated Staff will contact the family (phone or home visit) confirm that the parent/guardian received the letter as well as to discuss the absences and any parent/guardian concerns that may be resulting in the student's absences.
- Parent Family Liaisons and Other Designated Staff will develop an Attendance and Engagement Agreement for the student with input from the student and, as much as is practical, the parent/guardian. This agreement should be added to Skyward as an Attendance Note.
- Schools will document the contacts on the designated tracking document.

# 15 (15) Absences (Excused and/or Unexcused)

- The school will send a letter home detailing the importance of school attendance and cite the number of days absent.
- The building administrator or her/his representative will call the parents/guardians and schedule a meeting that will include the guardian(s), the student, and members of the school attendance improvement team.
- The Parent Family Liaison or Other Designated Staff will make a formal referral to the Regional Office of Education through the <a href="Connections Referral Link REVISED LINK NEEDED">Connections Referral Link REVISED LINK NEEDED</a>. All prior steps must be completed and documented prior to referral to the ROE. A copy of the referral will be provided to the building administrator for placement into the student's record. Enter into Skyward.

# Additional Information:

- The school has discretion in this process based on individual student circumstances such as
  documented long-term medical absences, documented family emergencies, and/or documented
  circumstances outside of the control of the student's parent/guardian. If letters are not sent to a
  specific student/family, the reason must be documented on the designated tracking document.
- In cases where a student has excessive or frequent absences due to "illness", the school may require medical documentation of illness (doctor's notes). Failure to provide documentation will result in future absences being coded as "Unexcused".

Your student has been absent for five (5) or more days. Currently, your student has # absences this school year. Although students have many legitimate reasons for absences from school, I want you to be aware of the possible implications of absences should your student's absences become excessive.

In the majority of instances, excessive absences will negatively impact a child's ability to learn as well as their academic performance and their prospects for promotion to the next grade. Good attendance is a key component to academic success, and students who attend regularly do better in school.

The school district's Promotion and Retention Guidelines state that a student must attend school for at least 90% of the school year. If your student does not attend at least 90% of school days, your student may be required to attend summer school in order to be promoted to the next grade. If your student attends school for less than 75% of the school year, your student will be retained without the option of summer school.

Additionally, the state of Illinois identifies individual students as chronic truants and/or chronic absentees based on the number of absences a student has. If a student is identified as chronically truant, there are possible sanctions for students and their families.

Illness and family emergencies happen, and we at SCHOOL are well aware of this. The faculty and staff are here to assist you in any way possible to help improve your student's attendance. Your student has been absent for ten (10) or more days. Currently, your student has # absences this school year. Although students have many legitimate reasons for absences from school, I want you to be aware of the possible implications of absences should your student's absences become excessive.

The school district's Promotion and Retention Guidelines state that a student must attend school for at least 90% of the school year. If your student does not attend at least 90% of school days, your student may be required to attend summer school in order to be promoted to the next grade. If your student attends school for less than 75% of the school year, your student will be retained without the option of summer school.

A student with 10 or more absences for any reason is considered a "chronic absentee" by the State of Illinois. Students with 10 or more absences may also be considered chronically truant. If a student is identified as chronically truant, there are possible sanctions for students and their families through the Regional Office of Education. Please be aware of the following information from the Regional Office of Education:

The State of Illinois law and school policy require regular daily attendance. Illinois School Code (Section 26-1) states: Whoever has custody or control of any child between the ages of 7-17 years shall cause such child to attend some public school in the district wherein the child resides the entire time it is in session during the regular school term.

SCHOOL will make every effort to inform parents of excessive student absences. Daily attendance is mandatory for successful completion of coursework. It is the responsibility of the parents/guardians to see that the student is in regular attendance. The law is specific, and parents/guardians must cooperate with the school to ensure that regular attendance is enforced. Illinois School Code (Section 26-10) states: Any person having custody or control of a child...who knowingly and willfully permits such a child to persist in his truancy within that school year, upon conviction thereof shall...be subject to not more than 30 days imprisonment and/or fined up to \$500.00.

At this time, due to the high number of absences this school year, your student is now at high risk of needing to attend summer school and may be retained in the current grade.
