SUBJECT: Dunlap Grade School Paving Project

BACKGROUND INFORMATION:

The West parking (Green) and playground area (Maroon) along with the access areas on the North and South sides of the building have been identified as violations in our Health Life Safety survey (Map Attached). The areas have deteriorated quickly and pose a safety threat to our students who play in that area and to our staff members who utilize those areas.

The yellow-highlighted portion of the North access area is the Village of Dunlap's property. I'm told by Mayor Esterdahl that there's been an agreement in place between the school district and the village since the "late 80s or early 90s" that the school district could use that area as long as the district agreed to maintain it. Unfortunately, there is nothing in writing to substantiate this agreement.

Bid specifications were prepared by Farnsworth and were collected on January 28th (Bid Tabulations Attached). The district requested two bids for the project; one bid for the milling and replacement of 2" of material, and one bid for the milling and replacement of 3" of material. Tazewell County Asphalt was the low bidder on each of the requests. The recommendation is to approve Tazewell County Asphalt as the bid winner for the 3" mill and overlay so that this work can be completed this summer at a total cost of \$207,548.
