

The Aubrey Independent School District is concerned about the presence of this new and potentially dangerous substance affecting the public health, safety and welfare of the citizens, particularly the youth of the Cities of Aubrey, Krugerville, and Crossroads. This product is sold locally in retail shops as a mixture of dried vegetation, or as incense, that when covered or mixed with certain specific chemicals, produces the physiological effects of a controlled substance similar to marijuana.

According to the National Drug Intelligence Center of the US Department of Justice (EWS Report 000006), the use of such substances can cause hallucinations, vomiting, agitation, panic attacks, tachycardia, elevated blood pressure, pallor, numbness and tingling, disorientation, loss of time awareness and, in some cases, tremors and seizures.
