Issue Summary:

Under Alaska law AS 14.03.120 all schools and districts must prepare annual school and district reports on school and student performance. The Alaska Department of Education and Early Development has established criteria for preparing school report cards.

In accordance with the law, each school and the district shall annually assess the school and student performance and prepare reports to the public on these assessments. These reports will help ensure that parents are actively involved and knowledgeable about their schools and their child's education

The information within this memo outlines the academic performance of the district as reported by the Department of Education and Early Development.

Background:

A notice about the Report Card to the Public will be sent to each site administrator for them to distribute to their community members and families. Links to the Report Card to the Public will be placed on the NSBSD website along with a letter from the Superintendent explaining how to access the information. The Report Card to the Public contains information about the previous school year.

Each School receives a Report Card, and also a one-page System for School Success sheet. The Report Card is best viewed online, and is not easily printable. It can be accessed here: <u>https://education.alaska.gov/compass/report-card</u>


