 - The teacher's Union does not approve of the calendar modification and a discussion occurred with the Superintendent and the District Union representative.
 - Our Superintendent is working with Board to perhaps waive the two days required by policy.

3 COVID Update for Alak School

- COVID cases have continued to increase since last Friday.
- Children are now involved in the COVID count this week.
- A COVID team meeting will convene on Monday October 4, 2021 at 5:00 PM to discuss further measures to protect students and the school.
- All District activities involving student travel has been postponed until further notice.
- Alak school remains in COVID RED and remote learning as well as meals are provided during the school day.
- Certified personnel prepare and grade student work packets and classified assist teachers, delivery packet and later meals to students.
- No word on our school bus.

Alak School Advisory Council SAC Meeting Minutes September 29th and 30th 2021

The SAC meeting was called to order on Thursday morning September 30 at 10:14 AM via Zoom and Cora Akpik was present and in person at Alak school.

Mr. Bolling contacted each absent member, provided a brief summary of the meeting, and ask for their vote on the modified school calendar results.

During the meeting, Mr. Bolling reminded each member present about the SAC Election on Tuesday October 5, 2021. He let them know Seats Four and Five were open for voting and two candidates have applied.

He provided a COVID update on the school to members.

He also provided a school calendar update to membership. Construction delays over the summer, resulted in school starting 5 contact days later and students had to make up those days. Arrangements were made to make up lost days with three in-service days in August and 2 Saturday school days in November. The Teachers Union had concerns about the additional two days for faculty and sent the proposal back to District leadership. The final outcome will require School Board members to vote on dissolving the two extra days of instruction or keeping this as they are.
