The district operates twenty-six (26) detention pond locations, primarily dry ponds. Sixteen (16) ponds are included in this contract, while the remaining ten (10) are maintained in-house by the Grounds Department. The ponds included in this solicitation typically require annual engineering review, permitting, or involve more complex operational and maintenance needs.

This solicitation sought to identify vendors to provide maintenance, repair, and related services to ensure the district's stormwater detention ponds operate safely, effectively, and in compliance with applicable regulations. Services include routine and corrective maintenance, inspections, vegetation and erosion control, sediment removal, bi-annual restoration activities, annual/bi-annual engineering review, and permitting.

A Competitive Sealed Proposal (CSP) #26-005 for *Detention Pond Maintenance, Repair, and Services*, was issued to over fifty (50) vendors. Four (4) responses were received and opened by the Purchasing Department on Tuesday, January 06, 2026.

An evaluation committee, comprised of representatives from various departments involved in graduation planning and production, was convened to review and assess the proposal. The committee evaluated the response based on the criteria outlined in the CSP. Each category was scored individually, and the totals were compiled to determine the overall ranking.

Based on the evaluation results, the committee unanimously recommends awarding the contract to **Stormwater Professional Group** as the primary vendor and **Yellowstone Landscape** as the secondary vendor.
