REGARDING EMERGENCY CLOSURE DUE TO DANGEROUS WEATHER**

WHEREAS, the South San Antonio Independent School District ("District") is a public school district located in Bexar County, Texas;

WHEREAS, on January 26, 2026, the National Weather Services issued a hazardous weather outlook affecting several counties in central Texas, including Bexar County, based on the possibility of a hard freeze and possible accumulation of ice;

WHEREAS, the District's Board of Trustees ("Board") finds that the weather as stated in the weather outlook on this day would likely create a dangerous situation for the District's students, staff, and community driving to school and work on the above mentioned day;

WHEREAS, the Board is authorized by Texas Education Code section 45.105 to expend funds of the District for purposes necessary in the conduct of the public schools as determined by the Board;

WHEREAS, per District Board Policy DEA (Local), the authorization to pay employees during an emergency closure shall be by resolution or other Board action and shall reflect the purpose served by the expenditure;

WHEREAS, The District has always been and will remain committed to providing the best possible educational opportunities for its students while at the same time keeping all District staff safe and being good stewards of its resources;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF THE DISTRICT;

That the School Superintendent is authorized to provide pay to all district employees for the above day when the District was closed due to hazardous weather.

Section 1. Effective Date. This Order shall take effect immediately from and after its passage by the Board.
