#### SITUATION

Northwest Regional ESD (NWRESD) has five elected board members and four appointed board members. Currently the open board positions are Zone 2 and Zone 4. Each of NWRESD's component district board's cast their vote to determine the member to represent them on the ESD board. The ESD board had previously (legislation action in 2007) been elected by citizens of the four counties served by the agency: Clatsop, Columbia, Tillamook and Washington.

• **Zone 4**: Beaverton (Beaverton and Sunset High School attendance areas), Clatskanie, Rainier, Scappoose, St. Helens and Vernonia school districts
