### **Background Information:**

The District needs to replace the lighting at Manor Athletic Complex. Administration intends to go through an interlocal purchasing cooperative for the contractor to replace/repair the lighting. Administration is first asking the board to approve the ranking of architects/engineers from pool of design professionals previously approved by the Board. Once we have an architect/engineer under contract, we will seek out a contractor to perform the work, which Administration will also bring the ranking to the Board for review and approval. Gil Engineering was previously approved and selected for the pool based on their demonstrated competence and qualifications.

### **Fiscal Implications:**

The District will need to bring on an architect/engineer to review the project. We will negotiate a fee for review and/or plans/specifications for the project (as determined by the architect/engineer). Once the architect/engineer is under contract, Administration intends to seek bids from vendors through an interlocal purchasing cooperative. The budget for this project is \$500,000.

### **Administrative Recommendation:**

Administration selected Gil Engineering, Inc. from the pool of architects/engineers at the April Regular Board meeting. Administration asks the Board to delegate authority to Administration to finalize and execute an agreement for their services.
