- **Good evening** - Our enrollment as of today is 2181, which is down 40 from the same time last school year. We are currently +22 (incoming vs outgoing) with our inter-district transfers to date. *(Note – historically, this time of year we see an enrollment decline/trend during the holiday season as many students travel outside of the area for the holidays and do not return until mid to late January.)
- **Financial Report** - Gabe has once again included a detailed financial report in the board packet. We continue to watch our expenditures with a needs vs wants mindset as we closely monitor forecasting reports and updates at the state and federal levels.
