PUBLIC HEARING

A public meeting was held to discuss the Coppell Independent School District's state financial accountability rating. Diana Sircar, Chief Financial Officer, presented information regarding the school FIRST (Financial Integrity Rating System of Texas) rating for 2022-2023. Coppell ISD received an "A" Superior rating with 94 points for the FIRST 2022-2023 (Fiscal Year 2021-2022) results.

Manish Sethi motioned to approve Ideal Impact to replace the HVAC energy management systems at CHS Ninth Grade Campus, CMS North, CMS East, CMS West, Canyon Ranch Elementary, Richard J. Lee Elementary, and the baseball/softball complex at a total cost of \$988,742 and authorize the Chief Operations Officer to finalize and sign the Agreement. Anthony Hill seconded the motion and the motion passed 6-0.

A motion to approve the purchase of eight (8) 77-passenger student buses from Longhorn Bus Sales, LLC at a total cost of \$1,114,960.00 was made by Nichole Bentley and seconded by Ranna Raval. The motion passed 6-0.

Anthony Hill motioned to approve the purchase of two (2) Isuzu NPR-HD crew cab landscaper trucks from Rush Truck Centers of Texas, LP at a total cost of \$159,800.00. The motion was seconded by Manish Sethi and passed 6-0.

The Proclamation regarding the Special Session was read aloud by Manish Sethi. Then Trustee Sethi motioned to adopt the Proclamation regarding the Special Legislative Session as presented. The motion was seconded by Nichole Bentley and passed unanimously 6-0.

Manish Sethi motioned to adopt policy changes to DC (LOCAL)- Employment Practices as presented and Ranna Raval seconded the motion. The motion passed 6-0.
