TASA Mid- Winter Conference Update	Dr. Braswell discussed the various Texas educational funding lawsuits filed by Thompson-Horton, The Equity Center, The Texas Coalition Lawsuit and the Mexican American Legal Defense & Education Fund (MALDEF).
	The Thompson-Horton group lawsuit will focus primarily on equity- efficiency, adequacy and property tax issues. Denton ISD joined this lawsuit along with 63 other Texas school districts representing 1.5 million students within Texas.
	The Equity Center's (Texas Taxpayer & Student Fairness Coalition) lawsuit focuses on fairness, attacking the target revenue system established in 2006 when lawmakers reduced the property tax rate and guaranteed that districts would get no less than the amount they received per student at that time.
	The Texas School Coalition also focuses on adequacy and property tax issues.
	MALDEF focuses on equity of property poor districts, adequacy and property tax issues.
	Districts typically sue the state on three different grounds: efficiency, adequacy and what's called "meaningful discretion." The Texas Constitution requires that the state provide efficient and adequate funding for public schools. The Texas Constitution also says that school districts must have the ability to choose how they spend money they bring in from property taxes.
	Jamie Wilson, Deputy Superintendent; Dr. Mike Mattingly, Asst. Superintendent; Ernie Stripling, Technology Information Officer and Rod Reeves also presented information from sessions they attended while at TASA Mid-Winter Conference

4 th Quarter Growth Report	Rod Reeves, Facilities Coordinator presented the growth report, regarding the general DFW housing market, economic indicators, Denton I.S.D. residential activity and enrollment projections as of the 4th Quarter 2011 and its impact to the overall growth of the Denton ISD. The report also provides trends in residential home sales, multi-family occupancies and growth in student population. Texas gained 204,500 jobs between December 2010 and December 2011 which continues to lead the nation in job growth. The state's unemployment rate of 7.2 % has been at or below the national rate with

	Denton County's rate at 6.3%. DFW ranks 2 nd in the nation for job growth with 57,300 new jobs as of November 2011. Denton ISD closed 779 new homes in 2011. 2Q12 will be key quarter for the 2012 new housing season. The District is in a position to add 850 additional students in the fall of 2012 with district enrollment of 25,705. Denton ISD could see enrollment growth of 4,873 students by 2016 with district enrollment of 29,728.
