- Superintendent's Cabinet Ensure all senior leadership team members understand the constituent services process and their role in carrying out the Board's expectations per the policy and procedures.
- District Leadership Meeting Inform principals and directors that the constituent services process is being implemented. Explain the role of school system leaders (school-based and system level) in carrying out the Board's expectations per the constituent services policy and procedures.
- PTA, CCIS, and Teacher Organizations Explain the constituent services process to the group members so they are aware of how the Board follows through on constituent questions or concerns. Use these groups as a means of informally evaluating the effectiveness of the procedures as perceived by the groups.
- News Media Issue a news release and conduct a news conference to inform the public of the Board's formal approach to constituent services.
- Board of Trustees' Meeting Periodically share, for the benefit of the citizens
