5. ACTIONS REGARDING:

A. Alternate Facilities Transfer, Tina Burkholder

This bond was for indoor air quality projects. There is a remaining balance in the Alternate Facilities fund and all projects are completed. Recommend we transfer \$500,000 to the Debt Service fund which will reduce tax obligations. Once final vendor payments are paid during the 2008-09 school year, a similar transfer will happen again next year. Will look at a project at Parkside in the future. This money cannot be saved since it was approved for specific projects.

> B. Certify the 2008 Pay 2009 Levy, Chuck Klaassen Truth in Taxation Hearing was held on December 2. Two people were in attendance. The levy is less than the pay 2008 levy and represents a decrease of 1.5% in total school property taxes. Total 2009 tax levy is \$12,896,829.37.

Discussion:

• Along with this tax savings, is consideration being given to savings we are seeing in fuel costs and putting this towards saving some of the budget reduction items. Cannot count on the fuel costs remaining low so would be hard to put that budget money for something else.
