State-wide Teacher Contract Settlements

IASB records that with 139 districts reporting, the average total package contract settlement with Iowa's teacher associations was 2.90%. By comparison, our total package settlement was 2.14%.

For the 139 reporting districts, the average for new money was nearly 2.0%. Belmond-Klemme only received 1.0% for the third year in a row.

For the 139 reporting districts, the median settlement date was March 29. We did not receive a signed master contract until May 17.

The Mason City School Board settled this week with its teachers after contentious bargaining. The teachers received a total package of 1.3%. They were on the road to arbitration, and the maximum legal settlement in arbitration this month was 1.1%.
