Cooke County Appraisal District

Nominations for Board of Directors have been received from County, Cities and School Districts in Cooke County to select Appraisal District Board of Directors. These Directors will serve a two (2) year term beginning January 1, 2024.

A ballot has been prepared listing the nominees (alphabetically by each candidates' last name) and sent to the presiding officer of the governing body of each voting unit.

Votes can be cast for one or more nominees.

Each taxing unit must cast its votes by written resolution and submit it to the Chief Appraiser by December 1, 2023. The Chief Appraiser will count the votes and declare the candidates who received the largest vote totals by December 10th, 2023. He will then immediately notify all taxing units and all candidates of the outcome. Even though there is only five positions and five nominations, it is still required to cast votes.

Any new members will be invited to attend the December meeting.

All members will be sworn in at the January 2024 meeting.
