 - a. All active CDs, (8 total), are deposited with the First National Bank of Pana with a total balance of \$162,587.79.
 - i. No CD activity to report until December 2021.
- 3. Checks Outstanding

 - b. \$250.00 check to Raegan Reed for PEF Scholarship
- 4. Checks clearing the PEF Regular Account
 - a. None
 - i. Charles Kramer has informed the PEF that he wanted his niece, Sierra

Hocq to be the recipient of the next Kramer Scholarship in 2022. The Kramers use the PEF as a tax deduction conduit for this scholarship and the PEF has no input into who wins the scholarship.

 - ii. School District to fund the remaining \$6,874.42.
- 4. Publicity

- 4. Superintendent Bauer informed the PEF Board that the school district will be picking up the \$12,000 commitment to pay the One-to-One Initiative originally committed to fund by the PEF for the school years ending in 2022 and 2023.
- 5. Superintendent Bauer presented a fund-raising idea involving the sale of personalized vehicle license plates through the State of Illinois.
 - a. Ishmael made a motion to further explore this program. Seconded by Kingery. All Yes.
