

MINUTES of a regular public meeting of the Board of Education of School District Number 117, Morgan and Greene Counties, Illinois, held at the Jacksonville Middle School, 664 S. Lincoln Avenue, Jacksonville, Illinois, in said School District at 6:20 o'clock P.M., on the 17th day of December, 2025.
