Re: Resignation Letter from Holmes Elementary School

I am writing to inform you of my decision to resign from Holmes Elementary School, as a Bilingual Teacher effective on August 19, 2013. Although I have enjoy working with Teachers, and Principal Mrs. Miller Johnetta.

This letter is to inform you that I hereby submit my request for released as a Bilingual Teacher for the Holmes Elementary School School District 152, effective August 19, 2013. The reasons to request the release are:

- It is very stressful for me to be dealing with such hostile member of the Staff, and for the benefit of my health, and my career, I no longer want to endure the continuous harassment from Ms. Adriana Carbajal, and the continuos threats of my student Evelyn Vazquez, and her mother Martha Lilia Vazquez which is the best friend of Ms. Adriana Carbajal and also a member of the PTA, which previously threaten me in the past that "if she wants she can get rid of me, or any other teacher", and later she complain to the Principal against me.
- I am very thankful for the opportunity you gave me to work for the Summer School, but disgracefully the same staff member Adriana Carbajal, [REDACTED] continue bullying me.
- Also Ms. Adriana Carbajal continue manipulating my student Evelyn Vazquez (6<sup>th</sup>. Grade) against me during summer school, and I understand that sadly this will not stop.
- I was very happy to be working with my students, until Ms. Adriana Carbajal used her friend Martha Lilia Vazquez, mother of my student Evelyn Vazquez, and my student Evelyn Vazquez who continuously has threaten me until the end of the past school year to complain against me so I can get fired.
- I want to mention that previously, we already had a meeting with three members of the same family and Evelyn Vazquez too.
- **I understand the danger that one student's accusations can cause to any teacher, if the student Evelyn Vazquez and her mother Martha Vazquez (Ms. Adriana Carbajal's best**

friend) accuse me in the future of something I did not do, as Evelyn has threaten me until the end of the past school year.

- Also I had the student Luis Hernandez during the summer school, from the same family of Evelyn Vazquez, the same family that my ex-Assistant Ms. Adriana Carbajal have used against me, Luis Hernandez mention to me that his mother Maria Hernandez, told him that she will come to the school to beat me up. ( Luis's mother was also in the meeting).
- **Although I love my students, I was very happy to be their teacher, and I have always threat my students in a very Professional manner. I believe it is for my best interest to resign, and not to put at risk my career as a Teacher, since I worry a lot because I will continue having the student Evelyn Vazquez, which until the end of the past school year, Evelyn continue threaten me, continuously to complain if she wants so I can get fired.**

I understand that until my request is approved, the District no longer has any obligation to pay me any salary, or fringe benefits after the effective date. I would like to apologize for my late resignation letter but I did not know what to do.

I would like to thank Mrs. Johnetta Miller for giving me the opportunity to be part of your staff, and I truly regret living Holmes Elementary School, I also want to thank all the Teacher's from Holmes Elementary who always were very willing to help me when I needed, and Mr. Oscar Farfan for being an excellent Teacher's Aid.
