State Laws and Regulations on Sex/Maturation Curriculum

District Policy and Regulation IHAMB and IHAMB-R

- Instruction in sex education may be offered in the district in conformity with Arizona law
- Representative committee established
- Board shall review the instructional materials
- Board shall hold two public hearings prior to approval of the curriculum
- Board shall maintain for viewing by the public the total instructional materials for lessons
- Superintendent shall develop and implement regulations
- Grades 7 and 8 curricula shall include instruction that sexual conduct with a minor is illegal

Opt In Curriculum

Why revise?

- Last revision was many, many years ago
- Policy references were outdated
- Media was outdated (e.g., references to overheads, filmstrips, etc.)
- Some facts presented were no longer accurate

Note: Amphitheater Public Schools has had a sex education curriculum in place for grades 5-8 for decades. This is a revision of that curriculum. It is not an entirely new curriculum or a new practice for our schools.







Scope and Sequence

Curriculum Focus Areas

- 1. Understanding the purpose of the reproductive system
- 2. Accurate nomenclature of the female and male reproductive systems
- 3. Functions of the reproductive systems
- 4. Health and hygiene
- 5. Attitudes and behaviors







What was added/revised?

- Age ranges for puberty for girls was lowered to age 8 from age 10
- Media selections and diagrams were replaced with more up to date materials
- Updated and aligned accurate vocabulary and definitions
- Data and factual information was updated
 - Example: The teen birth rate dropped 64% between 1991 and 2016.







What is next?

- The curriculum will be available for review by parents, teachers, and any interested community members.
- We will ask for final approval by the Governing Board in March or April.
- All schools will receive the appropriate curriculum for the grade levels they serve.
