ROBSTOWN ISD FACILITY RENTAL TERMS & CONDITIONS

For all facilities, I acknowledge/understand the following:

- Fees will be assessed for all non-school use of school facilities.
- ALL parking should be in designated areas only. Do not park in grassy areas.
- Any organization requesting usage does not have the authority to grant usage to another organization.
- Organizations granted permission to use a facility must understand that the agreement is for a specific facility on specific dates at specific times and does not imply the use of any other facility or equipment.
- Keys issued to employees must be returned to the central office on the next business day after usage.
- All doors, windows, and gates must be secured, and all lights must be left in the off position when leaving the facility.
- Organizations that use district facilities are responsible for any damage incurred during usage.
- Any existing damage should be reported immediately.
- All facilities must be left clean and in their original arrangement and condition. For facilities left out of order or unclean, a fee of \$100.00 per hour will be charged for custodial services, with a minimum of two hours for service.
- Due to staffing schedules, there may be instances when the facilities are unavailable.
 School-sponsored events take precedence over non-school events.
- The school district superintendent or representative may terminate a facility usage agreement at any time.

IABILITY INSURANCE: Non-school organizations must provide proof of insurance prior to approval to use district facilities. Robstown Independent School District and its personnel are not liable for any injury, person or property damage occurring during the time of use.
