Description: Frontline/IEP - eStar v3 is a digital management platform used by South San Antonio ISD to support the efficient documentation, compliance, and reporting of Special Education and Section 504 services. This system ensures that student paperwork, service records, evaluations, ARD/IEP documentation, and 504 plans are maintained in accordance with federal and state regulations. The platform streamlines processes for staff, provides real-time data tracking, and enhances communication between educators and families to support student success.

Historical Data: South San Antonio ISD has utilized Frontline/ESPED as the district's central platform for Special Education and 504 documentation, helping ensure compliance and improve workflow efficiency across campuses.

Recommendation: Approve the purchase of Frontline/ESPED services for the 2025–2026 academic year to continue supporting documentation and compliance needs for Special Education and 504 programs.
