Jackie Forbes shared that there are several bills about teacher and substitute shortages that have been making their way through the legislative process. There is a new one that would allow a sub to work 120 school days instead of 90 and another one would waive the application fee for short-term substitute teaching licenses if there were a declared disaster. Another bill moving through would provide full-time staff an additional five paid days off for mental health days. On another note, we have received several emails recently regarding the TRO, and we have been meeting as a COVID Task Force over the last few weeks where it was said if there are still questions to please contact the school nurse if you have issues specifically related to your child.

Several parents and community members shared their concerns about the temporary restraining order (TRO) and how the district responded by closing school on Monday, February 7. There was also concern about how the district would respond if the Governor's appeal was granted, the current leadership of the district, communications with the parents and public, test scores, and the resignations of two board members.
