## RESOLUTION OF THE BOARD OF EDUCATION DIRECTING THE SCHOOL TREASURER TO TRANSFER FUNDS FROM THE OPERATIONS AND MAINTENANCE FUND TO THE CAPITAL PROJECTS FUND

WHEREAS, by regulation (23 Ill. Administrative Code 100.50(d)), the Illinois State Board of Education requires that when revenues or other sources of funds are pledged to pay for a capital project or acquisition, the moneys shall be transferred into the Capital Projects Fund;

WHEREAS, the Board of Education of Oak Park Elementary School District 97, Cook County, Illinois wishes to authorize expenditures to pay for capital projects using revenues from the Operations and Maintenance Fund;

NOW, THEREFORE, Be It Resolved by the Board of Education of Oak Park Elementary School District No. 97, Cook County, Illinois, as follows:

- 1. The Board of Education hereby finds that all recitals contained in the preambles to this Resolution are full, true and correct and does hereby incorporate them into this Resolution by reference.
- 2 The School District Treasurer is authorized and directed to permanently transfer from the Operations and Maintenance Fund to the Capital Projects Fund the sum of Eight Million Dollars (\$8,000,000), to be used for District capital project expenditures as authorized by this Board, including but not limited to, the following: facility assessment improvement/maintenance projects, life safety and security projects, and learning spaces furniture and equipment.
- 3. All other motions or resolutions or parts of motions or resolutions in conflict herewith be and the same are hereby repealed, and this Resolution shall be in full force and effect immediately and forthwith upon its passage.
