**Background:**

Bloomington School District 13 participates in the Illinois Municipal Retirement Fund (IMRF) which provides retirement and related benefits to eligible District employees. Public Act 97-0609 became effective, January 1, 2012, which requires the District to post certain employer cost and participation information on its website. Public act 97-0609 was introduced January 1, 2012, with the intent to address transparency within school districts.

**Situation:**

Public Act 97-0609 was enacted to require school districts to develop a report that provides the public with information on all IMRF employees with a total compensation package that exceeds \$75,000 per year. The school district is required to present a report to the Board of Education and to place said report on the school district's website. For your convenience, I have attached the report that will be posted on the District's website.

**Recommendation:**

Public Act 97-0609 IMRF Compensation Report does not require any board action; Therefore, there is no recommended action.
