Dear Chief Boone, Director Esau, and Director Long,

On behalf of the Parkrose Neighborhood Association, thank you for your respective attention to reported issues at 12350 NE Sandy Blvd. in the City of Portland. We appreciate your staff's care in responding to the fire on that site on July 19th, 2023 and your assistance to test some of the materials collected from the fires. We understand the dangers posed to your staff by having to respond to these issues and recognize the bravery of your staff to still take care of Portland residents in the face of these dangers.

Currently, community members are still testing affected property and materials from the fire. We understand that there is an active fire investigation and a class action lawsuit filed in Multnomah County against several parties, including the property owner and the tenant.

## Given the seriousness and the extreme changes of the site's circumstances, we request that the City of Portland pause any issuance of permits regarding the site.

We also request that the City invoke its authority pursuant to City Code 33.262.100 (Off-Site Impacts, Documentation in Advance). Under this City Code, the applicant must submit a plan that identifies the anticipated off-site impacts of property use(s) in industrial zones and prevents and mitigates these off-site impacts to neighboring uses and to public health and safety. Some of these impacts are no longer hypothetical or speculative.

Residents have already been affected by the site. City of Portland staff time and taxpayer money have already been spent to respond to incidents at the site. The code explicitly allows the City to empower the Director of Bureau of Development Services to hold permits until these conditions are met by the applicant in order to protect the health and safety of residents, businesses, and our first responders. Using the authority in this existing City Code is also consistent with the City of Portland's Comprehensive Plan provisions adopted to protect the community.





We believe these actions to be reasonable in light of multiple incidents at the site. Using existing authority entrusted in the BDS Director provides a clear path for businesses that wish to build and operate here in our City. It helps these businesses work with residents, community institutions, schools, and existing businesses to prevent and mitigate risk from proposed demolition, construction, and operation.
