## Presentations/ Recognitions

Grayson Lovette, a fifth-grade student at Ginnings Elementary, was recently honored by the Texas Art Education Association and had her artwork displayed at the State Capitol as part of Youth Art Month Capitol Exhibit.

Harpool Middle was one of two teams from North Texas that qualified for the seventh annual Texas Quiz at the Texas Spirit Theater in Austin. The Texas Quiz Show is sponsored by the Texas State Historical Association in conjunction with Texas History Day.

Denton High's Farm Management Team placed second at the Future Farmers of America Area V competition at Texas A&M University in Commerce which qualified them for the state competition at Sam Houston State University. This is the first time a Denton High team qualified to attend state.

The Ryan High Track Team has again brought home state honors from the UIL Class 4A state track and field meet at the University of Texas at Austin. The boys' 1600-meter relay team proved to be among the fastest in the state for a second consecutive year. The team finished as state runner-up with a time of 3:14.59 and won the state silver medal.

Four Denton ISD teams qualified to compete in the Texas Interscholastic Swimming Coaches Association State Water Polo Championships at the University of Texas at Austin. Ryan High girls Water Polo Team posted the district's best overall finish by taking seventh place. This was the girls' fourth appearance at the state tournament. Guyer High girls Water Polo Team finished in ninth place. This was also Guyer's fourth trip to the state meet.

Ryan High Ryan Raiders boys' Water Polo Team finished ninth. This was their fourth appearance.

Denton High boys' Water Polo Team qualified for their first state tournament appearance and finished 13<sup>th</sup>.

Denton ISD also had three individuals recognized for their play at the state water polo tournament:

- Mandi Sutherland earned first-team all-state for Ryan.
- Christina Coon earned second-team all-state for Guyer.

• Cole Anthony earned all-state honorable mention for Ryan.

Hodge Elementary School Principal Sam Kelley was recently named a Top 10 Finalist for the 2012 Texas National Distinguished Principal award by the Texas Elementary Principals and Supervisors Association.

Jo Ellen Bobo, math teacher at Crownover Middle School, has received the 2012 Claudia A. Balach Teacher Researcher Award by the Professional Development School Research Special Interest Group of the American Educational Research Association. Mrs. Bobo was recognized for her work on a study titled: "Are Corrections Worth It? Action Research in Action."

Michelle Clayton, a second grade teacher at E.P. Rayzor Elementary, was recently named a winner in the fifth annual "Win With Classworks" contest. Mrs. Clayton was one of four, first-place winners in the top essay contest and one of only two winners from Texas.

Salary Recommendations Dennis Stephens, Exec. Director of Human Resources reviewed the salary recommendations for the Teacher step schedule. A person with a Bachelor's degree (BA0) and no experience will have a starting salary of \$47,600 a Master's (MA0) will have a starting salary of \$49,350 and a Doctorate (DOC 0) will have a starting salary of \$51,100. Employees would receive:

- Teachers with a bachelor's, masters or doctorate: 3 percent increase with \$1,000 minimum inclusive of step.
- Para-professionals, operations and exempt employees: 3 percent increase of the mid-point with \$700 minimum

Discussion of Middle School Attendance Zone Modifications Robert Bostic, Director of School Leadership & Instructional Technology and Rod Reeves, Facilities Coordinator reviewed the proposed middle school attendance zones in preparation for the opening of Middle School #7 in August 2013. The main objectives of adjusting the attendance zones is to relieve campus overcrowding; determine the impact of zone changes on middle school campuses; determine impact zone changes on future middle school sites; review transfer policies and make recommendations to maintain attendance zones; review student assignment policies to manage capacity concerns; minimize movement and dislocation of students; balance District program services; establish clear and definable attendance

boundaries and reduce school operational costs.

Discussion of Special Education Update Debbie Roybal, Exec. Director of Special Education updated the Board on the district's special education services. According to the TEA data, 9.7 percent of all students currently enrolled in the district have a disability higher than the state average of 8.5 percent. Mrs. Roybal and Dr. Rebecca Julius, autism and psychological services supervisor, also presented a report on the district's autism program. The district provides programming for students with autism (as defined by federal requirements) including those with both exceptional and limited cognitive skills and supports autism students through supplemental aides, lower student-to-teacher ratios, social adjustment classrooms and PPCD programs.

Deaf Education Update

Diane Allison presented the Board with an update to the Regional Day School for the Deaf (RDSPD) and the programs DISD provides to deaf students. RDSPD provides services to students with hearing impairments from 26 school districts in Cooke, Denton, and Wise Counties. Services have been located on Denton ISD campuses historically in a manner that promoted socialization between students who are deaf/hard of hearing with their hearing peers and allowed them to transition together from elementary to middle school and from middle school to high school.
