1. Board Recommendation to Repurpose Lamar Elementary School

Assistant Superintendent of Human Resources Dr. Matt Bolinger, Executive Director of Community Engagement Kendall David, Director of Facilities and Construction Brenda Garcia presented on the Board's recommendation to repurpose Lamar Elementary School as listed below:

WHY CONSOLIDATE?

Demographic Study

• Declining student population highlighted by the 2024 demographic study indicates an underutilization of facilities on the south-side of the District.

Efficiency with Tax Dollars

• Campus consolidation maximizes District resources, significantly lowering per-pupil expenditures and generating annual cost savings of \$2.5 million.

Rezoning

• Aligns with the District's comprehensive rezoning plan to maximize building utilization throughout the District.

Programming

• Allows for the District to expand Peter E. Hyland and the daycare + move POINT out of old San Jacinto Elementary.

State Challenges

• Lack of funding has forced a statewide trend of leveraging school consolidation as a budget reduction strategy.

CAMPUS REPURPOSE TIMELINE:

March 2024 – Budget Reduction Workshop: Consideration of School Consolidation as a tier 2 budget reduction strategy.

June 2024 – Demographic Study: Complete a demographic study and presented to the Board.

October 2024- GC2035: GC2035 reached consensus that Lamar would be repurposed

November 2024 – GC2035 Update: Board and Lamar community informed of the upcoming GC2035 recommendation.

December 2024 – Board Recommendation: GC2035 Presentation of the Long-Range Facility Plan

TENTATIVE TRANSITION PLAN

- 1. Pending Board approval, a survey will be sent on January 6th for Lamar teachers to select preferences.
- 2. Administrative Guidelines will be followed when reassigning Lamar teachers between Carver and Ashbel Smith
- 3. Teachers will not interview for carver or Ashbel Smith, but will interview if they choose the transfer list, the same process for anyone on the transfer list.
- 4. March 176th, assign teachers to Carver and Ashbel.
- 5. April 1st, transfer window opens, allowing principals to interview teachers interested in their campus.
- 6. Lamar Teachers not selected from the transfer list will be assigned to vacancies in the District.

Currently 38 teachers at Lamar with the majority will follow students and retaining every Lamar employee. The name (Lamar) will be voted on separately.

ACTION ITEMS

9530. CONSIDERATION OF APPROVAL OF THE REPURPOSING OF LAMAR ELEMENTARY AS OUTLINED WITHIN THE GC2035 COMMITTEE REPORT

Mr. Clem moved and Mrs. Guy seconded the motion **THAT THE BOARD APPROVE THE REPURPOSING OF LAMAR ELEMENTARY AS PRESENTED.** The motion passed with Mrs. Berrott-Tims, Mrs. Guy, Mr. Campisi, Mr. Martinez, Mr. Clem, and Mr. Sampson voting for motion. Mr. Renteria voted against the motion.

The District administration recommends repurposing Lamar Elementary School to accommodate the needs of Peter E. Hyland Alternative School and expand the District's day care services. This recommendation is part of a broader effort to optimize District resources in response to shifting enrollment patterns and aligns with the district's strategic plan goals of financial stewardship and operational excellence. Lower enrollment on the south side of the District has created an opportunity to consolidate facilities, ensuring resources are utilized effectively and equitably. Repurposing Lamar Elementary will allow for the expansion of critical programs while addressing the District's strategic priorities.

The name of Lamar Elementary School will be addressed separately the next Board agenda item.
