That the Board of Education

Approve the contract renewal to provide Nonprofit School Food Service for Fiscal Year 2016-2017 from Arbor Management, Inc. of Addison, Illinois, effective July 1, 2016 through June 30, 2017 for a 2.6% increase.

Background Information

The District is entering its second year of the contract with Arbor Management, Inc. as approved May 18, 2015. The above represents a 2.6% increase from last year. The projected amount to be paid to Arbor Management, Inc. (excluding commodity credits) is \$890.784.00 based on current pupil sales.
