DATE: July 28, 2015

Bulley & Andrews, the District's Construction Management firm, in concert with the District's architectural firm, STR Partners, upon receipt of construction documents associated with Bid Package #1 for the new Administration Building, prepared the appropriate bid notice which appeared in the Wednesday Journal issues of June 17, June 24 and July 1, 2015, announcing a bid opening on Tuesday, July 7, 2015 (please see attached notice).

Included in Bid Package #1 was work associated with temporary fencing, site utilities, excavation, concrete, structural steel, flagger, street sweeping, concrete barriers and surveying. Please see individual sheet per type of work (prepared by Bulley & Andrews) which delineates contractors solicited for bid submission running across each individual bid page and then any bid amount received within that company's specific column. Total estimated work (50% CD – Construction Design) for this work was \$1,263,100 and bids received totaled \$1,202,372 or \$60,728 or 4.8% under the 50% CD budget.

Concrete Barrier and Surveying work were significantly estimated under the \$25,000 mandatory bid threshold amount and both vendors (one per category of work) did not conform to the bid specification due to them not providing a bid bond. In reviewing this matter with legal counsel, we have been informed that to be in full conformance with bidding requirements, it would be best if the Board of Education formally rejected both of these bids and then have the Construction Manager work with both firms in providing the services needed within the confines of the dollar amounts identified by each.

Therefore, we are recommending, in concert with the District's architectural firm, STR Partners, and the District's construction management firm, Bulley & Awards, to award contracts to the identified vendors listed on the attached spreadsheet as well as reject the two bids (Concrete Barriers and Surveying). A formal resolution will be prepared for same and presented for Board approval at its August 11, 2015 meeting.





ORDINANCE NO. 2015 - 37

AN ORDINANCE ADOPTING PREVAILING WAGE RATES FOR THE YEAR 2015 TO BE PAID TO LABORERS, MECHANICS AND OTHER WORKERS PERFORMING CONSTRUCTION OF PUBLIC WORKS IN THE VILLAGE OF BROOKFIELD, COOK COUNTY, ILLINOIS

WHEREAS, the State of Illinois has enacted the Prevailing Wage Act (820 ILCS 130/0.01 et seq.); and

WHEREAS, the Prevailing Wage Act requires that the Village of Brookfield (the Village) investigate and ascertain the prevailing rate of wages as defined in the Prevailing Wage Act for laborers, mechanics and other workers in the locality of the Village employed in performing construction of public works, for the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Brookfield, Cook County, Illinois as follows:

Section 1. To the extent and as required by the Prevailing Wage Act, the general prevailing rate of wages in the locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Village is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Cook County area as determined by the Department of Labor of the State of Illinois as of June 2015, a copy of that determination being attached hereto and incorporated herein by reference. As required by the Prevailing Wage Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supersede the Department's previous wage determination and apply to any and all public works construction undertaken by the Village. The definition of any terms appearing in this ordinance which are also used in the Prevailing Wage Act shall be the same as in the Prevailing Wage Act. Any new determination made by the Department of Labor shall be substituted for the previous determinations.

Section 2. Nothing herein shall be construed to apply the general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village to the extent required by the Prevailing Wage Act.

Section 3. The Village Clerk (the Clerk) shall publicly post (keep available) for inspection by any interested party in the main office of the Village this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications for public works in the Village.

Section 4. The Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

Section 5. The Clerk shall promptly file, or cause to be filed certified copies of this ordinance with both the Secretary of State in Springfield, Illinois, and the Illinois Department of Labor.

Section 6. Within thirty (30) days after filing a certified copy of this ordinance with the Secretary of State and Illinois Department of Labor, the Clerk shall cause to be published in a newspaper of general circulation within the area a notice that the determination is effective and that this is the determination of this public body as provided in this ordinance.

Section 7. This ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
