- € 1. Early Childhood Initiative Community Coordinator from September 1, 2025, to August 31, 2026. This \$1,500 in funding is to be used within the contract period to pay the salary of the local coordinator and related expenses.

# Early Childhood Community Coordinator Responsibilities include:

- A. Share updates with the Northland Foundation about early care and education news and happenings in your community, especially in relation to licensed child care, as well as consider participation in special project opportunities.
- B. Complete required narrative and financial reports on the progress of the Early Childhood Initiative for their community.
- C. Participate in the Early Childhood Regional Alliance Meetings.
- € 2. Child Care Mentoring Project Interested Early Childhood Coalitions will build connections and provide support to licensed child care programs during July 25, 2025, to June 30, 2026. The Child Care Mentoring Project is designed to support the social-emotional well-being and school readiness of young children.

#### € Child Care Mentoring Responsibilities include:

- A. Work with 4-6 Child Care Programs from July 25, 2025, to June 30, 2026.
- B. Plan 4-6 sessions focused on social-emotional development for each program.
- C. Share information about Parent Aware and Early Learning Scholarships
- D. Collect required evaluation data and provide information to the Northland Foundation.
- E. Participate in Learning Community Meetings.
- F. Complete Final Project Report.

Participating sites will invite approximately 4 to 6 licensed child care programs to receive mentoring support from an Early Childhood Family Educator, Parent Educator, or Mental Health Specialist who will offer virtual and/or onsite visits to promote skill-building in the areas of healthy social-emotional development and trauma-informed care. Funding may be used to support staff time to coordinate the project and for an early care and education professional to visit participating licensed child care programs 4 to 6 times by June 30, 2026. Funding can also be used for materials/supplies and travel (if needed). It is anticipated that each will be one hour plus one hour of prep/wrap up time.

€ 3. Early Learning Scholarship Outreach Partner - The Northland Foundation has been serving as the Minnesota Early Learning Scholarship Area Administrator for Northeast Minnesota (Region 3) for the Minnesota Department of Education since 2017. This opportunity would assist with spreading the word about Early Learning Scholarships through your organizational and community efforts and providing resource navigation support, especially for children in priority populations (e.g., foster care, child protection, teen parents, homelessness, etc.). A total of \$2,500 in funding support will be available for your efforts for the period July 25, 2025, to June 30, 2026. Funding may be used to support staff time, outreach events, as well as provide incentives (food/snacks, children's books, gift cards, etc.), scholarship application materials, and other outreach resources.

# Responsibilities include:

- Serve as an Early Learning Scholarship Outreach Partner, targeted children from priority populations for the period July 25, 2025, June 30, 2026.
- Participate in training sessions about the Early Learning Scholarship program provided by the Northland Foundation.
- Share information about Parent Aware and Early Learning Scholarships with your networks, program participants, especially newborn units at regional hospitals, as well as other local and regional partners.
- Provide resource navigation supports.
- Collect required outreach data and provide information to the Northland Foundation on a quarterly basis (reporting template to follow).
- Share updates at Learning Community Meetings when possible.
- Maintain project records and receipts.

€ **4. Prenatal to Grade 3 Program** from August 1, 2025, to July 30, 2026. This \$1,000 in funding is to be used for expanding Prenatal to Grade 3 planning and implementation. Larger school districts or multiple school district service areas can make a case for additional funding.
