

**COLLIN COUNTY COMMUNITY COLLEGE DISTRICT
BOARD OF TRUSTEES
Meeting Minutes
October 28, 2014**

The Collin County Community College District (“Collin College” or “District”) conducted its regular monthly Board of Trustees meeting on October 28, 2014, in the Board Room, Room 139, Collin Higher Education Center, with Chairman Mac Hendricks presiding. Trustees in attendance were Ms. Stacy Anne Arias, Dr. J. Robert Collins, Mr. Andy Hardin, Ms. Jenny McCall, Mr. Adrian Rodriguez, Mr. Larry Wainwright, and Ms. Nancy Wurzman. Other attendees included District President Cary A. Israel, Collin College administrators, faculty, students, staff, vendor representatives, and community members.

CALL TO ORDER

Chairman Hendricks called the October 28, 2014, meeting of the Board of Trustees of Collin County Community College District to order at 5:31 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

ADJOURNMENT TO CLOSED OR EXECUTIVE SESSION

Chairman Hendricks recessed the meeting to closed session at 5:32 p.m. in Room 135, Board Conference Room, as authorized by Article 551.001, Texas Government Code, Sections 551.071 Consultations with Attorney; 551.072 Deliberations about Real Property; and 551.074 Personnel Matters.

OPEN SESSION

2014-10-3-2 Appointment of Collin College District Trustee, Place 7

WHEREAS, with the resignation of esteemed Trustee Tino Trujillo in July 2014, a vacancy resulted for Place 7 on the Collin County Community College Board of Trustees, AND

WHEREAS, a Search Subcommittee consisting of Chair Dr. J. Robert Collins and members Mac Hendricks and Nancy Wurzman was appointed to process applications, hold interviews and make recommendation for the appointment of Trustee, Place 7, to serve until the next scheduled election in May 2015, AND

WHEREAS the Search Subcommittee reviewed all applications and held interviews with seven (7) applicants on September 17 and 18, 2014, AND

WHEREAS the Search Subcommittee has made its recommendation to the full Board of Trustees, THEREFORE,

BE IT RESOLVED, at the recommendation of the Board Selection Committee, that the Board of Trustees of Collin County Community College District approves the appointment of Steve Cone, as Trustee, Place 7, to serve until the next scheduled election in May 2015.

Dr. J. Robert Collins said the Selection Committee was comprised of members Mac Hendricks and Nancy Wurzman; Trustee Collins served as chair. The committee reviewed a number of applications and used a fairly stringent process in selecting the finalists and in bringing Steve Cone forth to the full board for consideration.

2014-10-3-7 Approval to Not Participate in the State Employee Charitable Contribution Program

BE IT RESOLVED, that the Board of Trustees of Collin County Community College District approves an action to not participate in the State Employee Charitable Contribution Program.

President Israel explained that the District has not participated in the State Employee Charitable Contribution Program since 2011 with the reason being that the program has a 9 to 10% fee for collection of monies. If the college collects monies directly, all funds go to scholarships. He said it is fiscally sound to do so; however, under state law the District must take action to opt out of the program.

On motion of Ms. Arias, second of Ms. McCall, the Board of Trustees of Collin County Community College District unanimously approved an action to not participate in the State Employee Charitable Contribution Program.

Dr. Collins said it would be interesting to compare the two by running the same courses in the same semester of similar sizes then review comparable outcomes.

Dr. Ann Beheler, Executive Director of Emerging Technology Grants, answered Dr. Collins' question regarding Bid 3606, Annual Contract for Curriculum Development for the National Information, Security and Geospatial Technologies Consortium (NISGTC), and Bid 3694, Annual Contract for Curriculum Services for Online Conversion. She said seven colleges have committed to the curriculum. Courses have been created in a fashion that will match and each of the colleges in the consortium will have various course offerings from the curriculum. Dr. Beheler said federal grant programs at other colleges and universities have access to the curriculum.

President Israel praised Dr. Beheler's work saying she has done a tremendous job and produced tremendous results.

Budget Status Report 8/31/14

Expenditures exceed revenues by \$6,090,777 for the month ending August 31, 2014; however, year-to-date revenues exceeded expenditures by \$10,952,890.

Revenues exceeded expenditures by \$8,483,805 for the month ending September 30, 2014. Year-to-date revenues exceeded expenditures by \$8,483,805.

Investment Schedule 8/31/14

President Israel announced the following:

1. The Board of Directors of Sigma Kappa Delta have recognized Collin College's Chi Gamma chapter as an Outstanding Chapter with the designation of 2014 Ivy Chapter. Chi Gamma was applauded for their "dedication and steadfastness" in continuing to be

active and thriving. Thank you to our Chi Gamma members and faculty advisors Lauryn Angel-Cann, Michael Baker, and Julie Sears.

2. For the third time in a row, Collin's Surgical Technology program had 100% pass-rate for the Certified Surgical Technologist examination. In addition to the great news about the pass rate, the Accreditation Review Council on Education in Surgical Technology and Surgical Assisting (ARC/STSA) has notified us that the progress report for our program has been reviewed and accepted with no further information requested.

Acknowledgements go out to our surgical technology students, Senior Vice President Colleen Smith, Vice President/Provost Sherry Schumann, Dean Abe Johnson, Program Director Jeanne Glapion and all the faculty and staff involved in the program.

3. Collin College has been named as a TOP SCHOOL in the 2015 Military Advanced Education Guide to College & Universities – for the third consecutive year.
