A Regular Meeting of the Board of Trustees of Kaufman ISD was held on Monday, November 17, 2025, beginning at 5:00 PM in the Kathy Covington Administration Building, 1000 South Houston Street, Kaufman, Texas 75142.

CALL TO ORDER: Establish a quorum

Board Member Lindsey Abell led the Board in the Prayer and the Pledge of Allegiance to the US and Texas Flags.

DISTRICT CELEBRATIONS

Jenny Henricks recognized School Board Students of the Month from each campus.

Jennifer Baker, Principal at Lucille Nash Elementary, showcased the 5th Grade's new House Sorting System. At the beginning of the year, students were sorted into different "Houses". They work collaboratively as a team to earn points, participate in challenges, and receive rewards throughout the year. PUBLIC HEARING

A Public Hearing was held at 6:15 pm to discuss the Financial Integrity Rating System of Texas (FIRST) results. Grant Miller, Chief of Finance and Operations, reported that Kaufman ISD received a "passed" status and a "Superior Achievement" rating. This marks the 23rd consecutive year that KISD has received the highest possible FIRST status and rating. Mr. Miller stated, "The district's FIRST accountability rating ensures that Texas school districts are accountable not only for student learning but also for achieving these results cost-effectively and efficiently." INSTRUCTIONAL FOCUS / PRESENTATIONS

Amy Keith presented the BOY MAP. LASO 4 Cycle is open and offers additional grants to support school improvement and curriculum implementation. This grant would continue to support curriculum implementation, training, skill-building, development of the observation and feedback cycle, and instructional leadership coaching.
