I am requesting permission from the Finance Committee to purchase a used forklift for the Sheriff's Office. This lift would be used in the pole barn at the jail to move PPE items as well as unload trucks and store items that are ordered in bulk.

I have been in contact with Chris Mumford from Len's Lift in Alpena to assist with getting 3 quotes. Len's Lift does not primarily sell used lifts but does preventive maintenance on most of the lifts in the area. He has a couple clients locally that are selling their lifts that are in good shape and would fit our needs. Chris does have access to other vendors out of the area that sell used forklifts but he does not know the maintenance history of those lifts.

I have obtained quotes from Len's Lift for 3 used forklifts. All lifts have working safety features and Len's Lift will include a training class for operators. The difference in the lifts is the lifting capacity, tires, and hours on each unit.

Estimate #20036 \$7,000. 20102 hours on unit, cushion tires (indoor), 5000 lb lifting capacity.

Estimate #20035 \$6,000. 5240 hours on motor unknown on unit, Pneumatic tires (outdoor), 2400 lb lifting capacity.

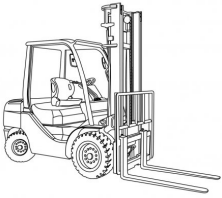
Estimate #20034 \$5,000. 15870 hours unit, cushion tires (indoor), and 2400 lb lifting capacity.

Estimate #200224 is located at a local business, we believe this lift would fit our needs.

I would like permission to apply to the First Federal of Northern Michigan Legacy Foundation for \$2,000. If awarded the \$2,000, we would then use the remaining \$3,000 from the Sheriff's Office Vehicle Maintenance line item # 101.301.934-000.

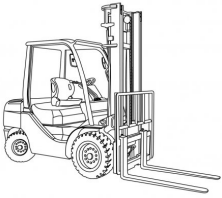

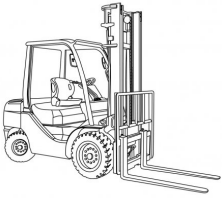
